Dallas - New Site Of TVH Headquarters

Present Location Outgrown; Facilities Inadequate

THE VOICE OF HEALING announces that it will soon move its headquarters to Dallas, Texas. The move seems to be advisable for several reasons. Shreveport printers are unable to handle the growing volume of TVH circulation. Each month the magazine goes into well over a hundred thousand homes, and if we estimate five persons to a family, it means that the magazine directly influences over half a million people.

The cost of the freight alone, in shipping magazines from the Dallas-Ft. Worth area, is nearly one half our entire postage charges. Taxes and other charges are also considerably higher here than in Dallas.

The new offices are to be located at 1600 Bonnie View, which is in the South part of the city, just three and a half miles from the heart of the business district. As the picture shows, the property lies in a setting of trees. At the time of writing, the foundation has been laid, and during the coming week, the walls will be in the process of erection. The plans envisage a modern office building, with approximately 6500 square feet of floor space.

On April 1, the associate editors met at St. Louis, Missouri, for the purpose of ratifying our new constitution. After two days of prayerful consideration, the constitution, with certain amendments, was passed unanimously. Besides the two original directors, five new directors have been added, which include Gayle Jackson, Raymond T. Richey, Velmer Gardner, Jack Coe and L. D. Hall. Brother William Branham has graciously accepted the position of honorary director. This gives the directors the benefit of his advice without necessitating his presence at all the business sessions, which he would be unable to attend, because he is out of the country much of the time.

The constitution of TVH provides assurance that the unique policies of TVH will be perpetuated. No funds from the corporation may go to an individual (except in the payment of salaries) but must be used in the promotion of the Gospel.

We regret to announce that our highly efficient assistant editor, Miss Anna Jeanne Moore, who has been with us since our beginning, will be leaving us in a couple of months. She plans to engage in evangelistic work for several months on the continent of Europe before returning to America.

WHO IS ELIGIBLE TO BECOME ASSOCIATED WITH THE VOICE OF HEALING?

We get many inquiries from time to time as to the qualifications of those who desire to become associated with THE VOICE OF HEALING. Briefly we may say that they should: (1) Have a mature healing ministry. (2) Be willing to accept and abide by the articles of the constitution. (3) Have a character that is without reproach. (4) Be willing to practice the ideals of THE VOICE OF HEALING fellowship. (5) Labor for the unity of God's people. (6) Be willing to help to the best of their ability in increasing the circulation of the magazine. (7) Be an evangelist and not a pastor.

OUR BUILDING PROGRAM IN DALLAS

The new building in Dallas will be a modern office building in every respect and when finished will perhaps have a value of over \$30,000.00. Brother Jack Moore is superintending the building, and the editor is giving much of his time with the job. Nevertheless, the financial burden of this move is extremely heavy, and we shall appreciate the prayers and interest of our readers in this undertaking. We are certain God will see us through.

THE BRANHAM STORY TESTED BY C.P.A. INVESTIGATOR

The following remarkable letter tells the interesting story of J. H. Buzzell, a C.P.A. Specialist who decided to launch an impartial investigation into the authenticity of the Branham story. This unsolicited account of Mr. Buzzell's findings will open the eyes of many doubters.

The Voice of Healing Shreveport, Louisiana Gentlemen:

While I have always believed that the promise of Christ should be fulfilled, that signs shall follow those that believeshall lay hands on the sick and they shall re-cover", I felt that due to man's failure to avail himself of this gift through the centuries it had perhaps become lost.

Of course, from time to time I had heard of "cures" but when an attempt to trace them down was made, it developed that the person who had reported them had not personally seen them, that it was a friend, and when that lead was followed it was found to have been a friend of a friend who had seen it, until the evidence became so far removed that it dropped into the category of mere "rumor".

With this background, when my wife secured a copy of the book "William Branham, A Man Sent from God," I read it, and as we were scheduled to be at our summer home in New Hampshire for the next two weeks I decided to check the accuracy of the reports.

While I little like the needless display of titles, yet it perhaps is not out of place for me to call attention to the fact that one of my profession has to be accurate in the extreme and must be well versed in making checks of facts and figures, rather than take some one else's "say-so". This education and training stood me in good stead in such an investigation of the state investigation as I was about to undertake.

I started my quest in utmost good faith. I purposely kept my mind "open", ready to acknowledge the accuracy of the events narrated or face refutation of the incidents. I picked what I considered a reasonable "cross section" of the events and started my work.

Numbered among what I considered a fair "cross section" was the incident recounted on page 21. I wrote to the Chief of Police in Portland, Ore., inasmuch as it mentioned two police officers as having been at the meeting. I was told by the chief that he was forbidden by law to exchange information on any other than criminal work, and then only with other properly accredited law enforcement agencies.

I felt, for some reason, that this was an event that I wished to investigate. It represented two possible extremes. If it were untrue it offered what one would term a ' culous" narrative. On the other hand, if it could be substantiated it would be an outstanding factor. Therefore I tried another approach. I wrote to one of the Boston papers for the name of Portland's newspapers and received a reply stating that there were but two, one a weekly, the other an evening paper. I wrote to both, outlining enough of the re-port to identify it and the Oregon Journal assigned a reporter to the case that I might be given an accurate, first hand report. This, it seemed to me, was an unusual procedure, and one which I appreciated. That reporter contacted various people until he found an eye witness, and that witness recounted to the reporter what he had seen, a recital which in all important details coincided with the book's outline. That reporter ended his letter

of August 27th with these words, "The explanation of the actions of the 'demon possessed' man, and his quotations from the Bible explaining it, was most interesting to me."

In appreciation of this reporter's work I forwarded him a copy of the book. I mention this because it had a bearing on future actions on my part, upon which I shall touch a little further along.

I confirmed the healing of Mr. Daugherty's daughter in St. Louis, as described on pages 86 and 87; I confirmed the healing of Miss Carter, as told on page 200, and have Miss Carter's letter stating that she is now "well and happy today".

The Waukegan News-Sun, of Waukegan, Michigan, sent me clippings from their paper telling of Mr. Branham's visit to that town, the Jeffersonville Post, of Jeffersonville, Indiana, sent me a copy of their publication of November 3, 1949, telling of Mr. Branham's

Another case which I investigated was that of a man in Calgary, Alta., Canada, who had an injured vertebrae disk. The incident is described on page 162. I checked with a surgeon that only surgery could help such a case. I wrote the "Albertan", one of Calgary's newspapers, and received a reply from Mr. S. McClelland, Assistant Circulation Manager, in which he told me that their supply of the particular edition I desired had become exhausted, but he had his stenographer give me an excerpt of the case of Mr. John Andre, forty-six years of age, an excerpt which covered about an entire page of single space typing. I must say that the response of the newspapers in the west and northwest was amazing to me. Furthermore it indicates to me that no one had previously been sufficiently interested to check

any of the events as I was doing.

I have also read Mr. Upshaw's statement in which he tells of his miraculous cure. I heard Mr. Upshaw many years ago and recall him distinctly because of the pitifulness of

his condition, the uselessness of one of his legs, the left as I recall it.

An eye-witness told me of his having attended the Kansas City meetings. He told how a woman near death from tuberculosis was brought by stretcher a distance of one hundred and fifty miles to attend the meetings. She was placed in a wheel chair and when after two days her case had not been reached, her husband, with the aid of some of the men, lifted her bodily, chair and all, on to the platform. Upon seeing her, Mr. Branham wheeled and said something like this, "Woman, your faith has healed you," and he turned to the husband and said, "Sir, your faith has healed your wife", and then, turning back to the woman he commanded in the name of Christ that the illness leave her. The eye-witness told me that the woman jumped from her chair and walked two or three times across the platform, with her arms in the air, doubtless in a gesture of thanksgiving. This man tells me that from all over the auditorium one could see the flesh reappear on her arms, limbs and cheeks, and see the clothes swell out as the body regained its weight. The next day she appeared before the meeting and announced that within the past twenty-four hours she had gained twenty-eight pounds.

One branch of my business is that of busi-

ness counselor and in that capacity I naturally have to get into the labor situation. I observed a newspaper article by a New Hampshire man which I thought to be erroneous and I wrote him correcting it. He received the correction very graciously and from that sprang a correspondence which branched out into other

Earlier in this letter I have said that sending the book to the reporter gave me an idea. That idea was to prepare a short foreword for the book, reproduce it on one of my machines and place a copy in the front of each book that I loaned, and I had decided that the loan of this book was perhaps the best method of home missionary work that I could do. Up to date I have purchased fifty of the books for this purpose. Some are returned, some are not.

In the course of events I supplied one such book to the newspaper correspondent to whom I made reference just above, and evidently he, in turn, mentioned the case to another newspaper correspondent, and you can

Questions and Answers

SOME SAY THAT THE BAPTISM OF THE HOLY GHOST IS RECEIVED BY THE LAYING ON OF HANDS, BUT OTHERS SAY WE SHOULD STICK BY "THE GOOD OLD WAY" OF "TARRYING" UNTIL WE RECEIVE.

WHICH IS THE CORRECT METHOD?

ANSWER:

One of the great distinctions between man's ways and God's is that if man had his way, he would have everybody go through the same cookie-cutter. On the other hand, God, while holding to basic principles, has a cer-tain variation in the manner in which He deals with different individuals. There is also a difference of ministries. This is brought out by Paul who says in 1 Cor. 12:4; "Now there are diversities of gifts, but the same Spirit. And there are differences of administrations, but the same Lord. And there are diversities of operations, but it is the same God which worketh all in all." We shall, therefore, find that the Holy Spirit is not always ministered to the people in exactly the same way.

It has been said that "the Old Testament is the New concealed, while the New Testament is the Old revealed." It is generally understood among Bible students that the pattern of many things in the New Testament is found in the Old. Favored individuals in Old Testament days received the Holy Spirit, although it is evident that they received it not in the same degree as it has been given since the Ascension of Christ. (John 7:37-39).

HOW DID PEOPLE RECEIVE THE HOLY SPIRIT IN OLD TESTAMENT DAYS? Moses went up into the Mount and tarried before the Lord forty days, and when he came down his face shone with the glory of God, so great was the power of the Spirit upon him. (Exod. 34:29). God then used him to minister the Spirit to others. In the case of the Seventy Elders, God took of the Spirit that was upoo Moses and gave to the Seventy. (Numbers 11: 16-17). But on Joshua, Moses laid his hands and the Spirit of wisdom came upon him. (Deut. 34:9).

Saul received the Holy Spirit as a band of prophets prophesied. (I Sam. 10:5-6). Samuel took a horn of oil and anointed David and the Spirit came upon him. (1 Sam. 16:13). A double portion of the Spirit came upon Elijah as the latter saw Elijah being caught up to heaven. (II Kings 2:9-14).

Various Ways in Which God Heals People

Notice, by way of illustration, the various ways in which the healing virtue of the Spirit of God is administered. First, by the laying on of hands. (Mark 16:18) Second, by the anointing with oil and the prayer of faith. (James 5:13-15) Third, by the spoken Word of God. (Psa. 107:20) (Matt. 8:8-10) Fourth, by means of clothe which have touched the by means of cloths which have touched the bodies of those who have special faith for healing. (Acts 19:11-12) (Matt. 9:21) Fifth, by some special point of faith contact, as the shadow of Peter. (Acts 5:12-16) Sixth, by a look, as the children of Israel who were healed by looking at the Brazen serpent. (Numbers 21:8) Seventh, by command, as Peter's command to the lame man to "rise up and walk." (Acts 3:6). There are other means by which God has healed people, but enough has been mentioned to show the diversity of methods by which God works.

Receiving The Holy Ghost on The Day of Pentecost

On the day of Pentecost, the Holy Spirit was given without any laying on of hands, but the Spirit came "as a sound from heaven as of a rushing mighty wind." (Acts 2:2). Likewise at the House of Cornelius the Spirit was given without any human instrumentality being used, other than the preaching of Peter. (Acts 10:44-45).

However, in several other distinct places, the Holy Spirit was given by the ministry of laying on of hands. This was true in Samaria (Acts 8:14-17). This was the case with Paul receiving his baptism. (Acts 9:11-17). Again, hands were laid upon certain men in Ephesus, by the Apostle Paul, and they received the

by the Apostle Paul, and they received the Holy Ghost. (Acts 19:6).

IS THERE ANY PREFERENCE IN THE TWO METHODS WHICH ARE ESPECIALLY MENTIONED IN THE NEW TESTAMENT, BY WHICH PEOPLE RECEIVED THE HOLY GHOST? THE ANSWER IS FOUND IN THE CIRCUMSTANCES. OF THE CASE:

1. Whether hands are laid upon people to receive the Holy Ghost or otherwise, it is essential that they prepare their hearts for the experience. The Holy Ghost is given to those that obey Him. (Acts 5:32). A careless Christian needs to do some deep searching of heart, f he is to bring his life into an attitude of full obedience to God. Paul enjoins to "lay hands suddenly on no man." (1 Tim. 5:22). The hundred and twenty received the Holy Ghost after they had spent days in prayer and waiting upon God. (Acts 1:14). The Lord allowed Paul to wait in prayer and fasting three days before He sent Ananias to lay hands upon him. (Acts 9:9-11). Cornelius was in prayer and fasting at three o'clock in the afternoon, when the angel appeared directing him to Peter, through whose ministry he received the Holy Ghost. The angel said, "Thy prayers and Thine alms are come up for a memorial before God." (Acts 10:4). The disciples at Ephesus had received the searching teaching of John the Baptist before Paul laid hands upon them and ministered to them the Holy Ghost. (Acts 19:3-4).

2. There needs to be a complete surrender 2. There needs to be a complete surrender of the life to the Lord, if one is to receive a satisfying experience with God. Saul received the Holy Spirit without any real preparation in spiritual things. With him it was "easy come", and, alas, later it turned out to be "easy go." (1 Sam. 16:14). The Spirit of the Lord left him and an evil spirit took the place.

took the place.

On the other hand, when Elisha desired a double portion of the Spirit, Elijah told him he had asked a hard thing. (II Kings 2:10). He knew that there were great decisions of soul that needed to be made, and not every one was prepared to make them. However, Elisha was prepared—whatever the cost, he must have the Blessing. The double portion came, and the blessing remained, without interruption, during a long life, which was marked by unique blessing and power.

Moses' forty days before God on the Mount lifted him into a realm of faith that, at the age of one hundred and twenty, "his eye was not dim, nor his natural force abated." (Deut. 34:7). The richest experiences with God come to those who set apart time to wait upon Him.

3. What we have said, however, is something entirely different than the so-called endless begging for the Holy Spirit. Man can-not earn the Baptism of the Holy Ghost. He cannot make himself more holy. The Holy Ghost is already on earth and does not have to be prayed down out of heaven. If the individual has truly repented and made a full consecration to God, he is ready to receive the Baptism of the Holy Ghost. There is no need for a long waiting period. He is to understand that the Holy Ghost is ready to come into his heart the moment that he is

ready to receive Him.

One of the gravest mistakes that people make is the idea that God will hear them for their long prayers, or much repetition. One of the first things that Jesus said about prayer was, "But when ye pray, use not vain repetitions, as the heathen do; for they think that they shall be heard for their much speaking." (Matt. 6:7). It is wonderful to see a sinner thoroughly repent even as the publican, who heat upon his breast saving "God be who beat upon his breast, saying, "God, be merciful to me a sinner." (Luke 18:13). But there came a time when the publican had to do something else. He had to go down to his house believing he was justified. Long ag-onizing prayers, begging for salvation, once repentence has had opportunity to express it-self, only discredits the grace of God which is given freely to whosoever will. Likewise in the matter of healing, people who go about day by day, begging God to heal them, and at the same time refusing to believe God's word that He meets them then and there, usually don't get healed. Healing is a gift; it must be taken and appropriated.

Likewise is it in the matter of the Baptism of the Holy Ghost. When the heart is ready, God is ready. No long, agonizing seasons of waiting for the blessing to come are necessary. The Holy Ghost is ready to come in without further delay.

Naturally God has His times and places. One is not apt to receive the Holy Ghost in a strengthers of doubt and upheliaf. He needs

an atmosphere of doubt and unhelief. He needs to be with those that have faith. God has His special ministries also. Though mighty miracles took place under the ministry of Philip, yet apparently he did not have the ministry of the Spirit. When Peter and John came down they laid hands upon the people and they received the Baptism. Where the heart is hungry, and such a ministry is present, the Scriptures teach that the normal way to receive the Holy Ghost is through the laying receive the Holy Ghost is through the laying on of hands. The fact is that many thousands these days are receiving the Holy Ghost by the laying on of hands. Where sound Scriptural teaching goes with it, there can be no objection to this Biblical method. However, neither should we in any way deprecate the Baptism of the Holy Ghost received without the laying on of hands. Either way it is God who gets all the glory. (The laying on of hands for Gifts is an entirely different matter and was discussed in Ouestions and Answers in was discussed in Questions and Answers in the February issue.)

When Mac Arthur Prayed

The Lord's Prayer has been repeated under many strange and varied circumstances, but never in more grim and dramatic surroundings than at Seoul, Korea, after General MacArthur's victory at Pu-

The date was September 29, 1950. The hour, shortly before noon. The place, the war-torn, half demolished Capitol building at Seoul. Fires were still burning in the city. Fighting was going on ten miles awav.

Only a few days earlier, the red armies were pressing for a Dunkirk that threatened to drive our out-numbered forces into the sea.

General MacArthur had sought the



mind of God in prayer, for guidance, to avert this slaughter of American boys.

By what is regarded as one of the wisest strokes in military history, he led forces by water above the Communist hordes, attacked, divided them and cut their

armies to pieces.

Then a few days later, heading a cavalcade of American and Korean officials, newspapermen and photographers, he entered Seoul for the purpose of turning the city back to its rightful owners.

He began his address by a reference to the mercies of God and concluded with the Lord's Prayer.

General George Kenney, who was present, says: "You are impressed when you hear MacArthur mention God. He is deeply religious and his sincerity is so evident that you realize at once that here is no pose. The reverence is not there as a matter of form. It is there because General MacArthur believes in God."

Coming to that part of his address where he was about to lead in prayer, the General hesitated for a long, solemn moment.

In the seated crowd before him, squeezed into the benches where the legislators used to sit, were many camouflaged helmets or caps, and most were keeping them on their heads because of the occasional showers of broken glass.

When MacArthur said, "In humble and devout manifestation of gratitude to Almighty God for bringing this decisive victory to our arms, I ask that all present rise and join me in reciting the Lord's Prayer," he signalled with his hands for the crowd to stand.

There was the rumbling shuffle of many getting to their feet such as you might hear in church. Off came the camouflaged helmets, the canvas caps, the snappy blue Air Force hats, the Navy caps. Every head was bowed.

MacArthur's voice uttered the words which have come down the ages, slowly and with great feeling. The crowd went along with him in a low murmur. At the conclusion, "For Thine is the kingdom, the power and the glory, for ever and ever. Amen", MacArthur's voice became strained with emotion.

There was another pause and Mac-Arthur motioned for the men to be seated.

On went the helmets and caps again, as there was another tinkle of falling glass.

I like to feel that despite the awful times in which we live, that there are still leaders on the historical scene who believe in God, the Word of God and really pray. This fact is a ray of hope, a bright light in an otherwise clouded

Donald Gee Column Our Pulpit Illusions

Almost certainly it was my uneasy conscience that impressed upon me a passage I read the other day in a pastor's frank confessions.—"There is a world of difference between preaching to a crowd and talking to an individual. I brought Jimmy Locke home to supper after the evening service, and he took up the subject of my sermon. And immediately I caught myself toning down my own bold pulpit utterance. Up on the rostrum it is so easy to contrast things in black and white and to thunder 'no compromise!' But face to face with an individual caught up in the strains and tensions of daily life, one sees so clearly the difficulties he is up against that one is tempted to suggest an easier course than the one offered from the pulpit."

That, I confess, is exactly my own experience as a preacher. On several occasions it has occurred with respect to people's marriage tangles. It was brought home to me in a humiliating way not long ago after I had preached a bold sermon on the "Life that is to come." A business-man called to see me and suddenly said quite frankly, "What to

you really think, speaking man to man, about this business of death?" He was an utterly honest agnostic. I will not repeat my reply, except to say that in trying to meet sincerity with sincerity I was left with plenty of material for searchings of beart

of heart.

The pulpit has shocking dangers. The preacher knows what the people WANT him to say: he gets swept along by the excitement of the occasion, and even by the glory of the intrinsic truth of the word. He dare preach no other faith. But what the minister REALLY believes in his own heart stands revealed when he finds himself in precisely the same position as those to whom he has preached. Let all preachers of divine healing take note!

We still of "dynamic" preaching as something

Let all preachers of divine healing take note!

We talk of "dynamic" preaching as something oratorically, or emotionally, or even physically powerful. Is it? Are not the truly dynamic preachers and teachers the rather that choice company of God-anointed men who so thoroughly believe their own message that it is absolutely a part of themselves? With very few, if any, of the tricks of oratory, there is in what they say a solid, mighty impact of living truth that changes lives all the time. It is the force of deep sincerity. Truly dynamic preaching of the word, as distinct from mere pulpit theatricals, leaves behind it an impressive record of lasting work accomplished in the hearts and lives of those who hear it. But this genuinely Pentecostal power of the Spirit of truth never remains with a man who is not prepared to be truthful with himself. My private conversations, rather than my pulpit utterances, will help me to

know my own heart. "I myself also am a man" (Acts 10:26) said, in conversation, the first of all dynamic Pentecostal preachers. Let us cherish our mental, moral and spiritual manhood, lest professionalism in the pulpit ruins our souls.

sionalism in the pulpit ruins our souls.

God is merciful. If He demanded the full measure of consistency with our own messages from those of us who preach then who could stand? The Holy Spirit does appear to bless most graciously in spite of our fraility. Our hearts know their own bitterness in this matter. What shall we do about this awful gap between our best sermons and our best living? "Seek to live up to our preaching"—assuredly, by God's grace. But meanwhile, are we to quit preaching? Or are we to drag our preaching down to the level of our living? Not, as I think, necessarily. Let us continue to preach the truth as God gives us to see the truth, even though the vision soars far beyond our present attainment.

the truth, even though the vision soars far beyond our present attainment.

But let our pulpit utterances continually be checked, and corrected, and purified, and fortified by what we have to say on the same themes in ordinary conversation with ordinary people (NOT with other preachers). We need not aim at speaking from our pulpits as we would from our hearthrugs, any more than we want a man to speak on his hearthrug as he will from his pulpit. What we DO desire is always a passionate desire to be true. The Spirit of truth will most certainly be our Helper in this, and thereby lead us to that promised Power which to many is still a pulpit illusion rather than a saving fact.

Divine Judgment Saves Christians From Drunken Mob

A wire reached us one morning at our office in Mexico City. It was a frantic appeal from the Christians in a mountain village some one hundred miles distant. We were told that a persecution was breaking out, and to send help at once.

Any mob is dangerous. A drunken mob is more dangerous. A drunken, religious mob, set on defending their religion, is most dangerous of all. The leaders well know that once incited they will not only burn and destroy, but they will kill!

The Governor said that not only would he send soldiers, but he would go personally. Driving in an open car with two soldiers, the Governor and our lawyer drove the two-hour journey over dirt roads to the rebelling village. In the zocalo they encountered a mob of several hundred Indians, men, women and childen, milling about, and listening to the haranguing of a man on an improvised platform. They had been to the church, but the Christians had barricaded themselves inside, where they remained in fervent prayer, while the mob cried angry orders for them to come forth, beat on the wooden door and windows with machetes and clubs, but all to no avail.

The Governor ordered the car driven through the mob into the center of the zocalo. The mob formed a close circle about the car but stood back some ten feet, out of respect for the rifles and fixed bayonets of the soldiers.

Standing in the open car, the Governor lectured the drunken Indians. He reminded them of the laws of the land, which permit religious liberty to all native-born Mexicans, to worship God according to the dictates of their hearts. He also reminded them that the rioting would bring punishment upon the heads of the leaders if the mob did not disperse.

INCIDENTS SWERS TO PRAYER

Christ Appears to Crippled Girl and Brings Healing at Given Hour

(In this 20th Century miracle, God performed a healing that has defied the skeptic. The Fairmount (Minnesota) Daily Sentinel Newspaper, carried the full details in the September 3, 1941, edition. The Lord had shown Betty Baxter, desperately afflicted, that she would be healed at 3 o'clock on August 24, 1941. 2:45 P. M. of that day came and—)

-Mother came to my bedside. I said, "Mom, what time is it?"

She said, "Just 15 minutes before Jesus is coming to heal you."

I said, "Mom, take me in and place me in the big chair." She carried me in and set my twisted body in the chair and propped me up with pillows. I saw the people as they knelt on the floor around the chair. I saw my baby brother, four years old, and I realized I was so bent that I stood only as high as he did. He knelt down by me, looked up and said, "Sis, it's not very long now until you will be taller than me."

At 10 minutes of three my mother asked me what I wanted them to do. I said, "Mom, start praying, I want to be praying when Jesus comes." I heard her sobbing and praying for Jesus to keep his promise and come and heal my body.

HOW JESUS CAME

I didn't lose consciousness but I became lost in the Spirit of God. I saw before me two rows of trees, standing tall and straight. As I watched, I saw one of them in the center begin to bend until the tip of it touched the ground. I wondered why this one tree was all bent over. Then down the road I saw Jesus. He came walking through the trees and my heart thrilled as it always does when I see Jesus. He came and stood by the bent tree. He stood and looked at it a moment and I wondered what he would do. Then looking at me he smiled and placed his hand on the bent tree. With a loud crack and pop it straightened up like the other. I said, "That's me all right. He will touch my body and the bones will crack and pop and I will stand up straight and be well."

Suddenly I heard a great noise as if a storm were coming up. I heard the wind as it roared. I tried to speak above the noise. "He's coming. Don't you hear Him? He has come at last." Then all at once the noise subsided. All was calm and quiet and I knew in this quietness Jesus would come. I sat in the big chair, a hopeless cripple. I was so hungry to see him. All at once I saw a great white fleecy cloud form. It wasn't the cloud I was waiting for. Then out of the cloud stepped Jesus. It wasn't a vision, it wasn't a dream. I saw Jesus. As he came walking slowly toward me I looked on his face. The most striking thing about Jesus is his eyes. He was tall and broad and was dressed in robes of glistening white. His hair was brown and parted in the middle. It fell over his shoulders in soft waves. I will never forget his eyes. Many times when my body is worn and I'm asked to do something for Jesus I would like to say, "No." When I remember his eyes they compel me to go out into the harvest fields to win more souls.

Jesus came slowly toward me with his arms outstretched toward me. I noticed the ugly prints of the nails in his hands. The closer he got to me the better I felt. When he came real close I began to feel very small and unworthy. I wasn't anything but a little forgotten girl who was deformed and crippled. Then all at once he smiled at me and I wasn't afraid anymore. He was my Jesus. His eyes held mine and if I ever looked into eyes filled with beauty and compassion, they were the eyes of Jesus. There aren't many people I've seen who have eyes like Jesus. When I see one who has that love and compassion in their eyes I wish I could just stay close to them. That is the way I feel about Jesus; I want to live as close to him as I can.



(Article Appearing In Popular Chilean Newspaper)

In a brief, but concrete and objective public declaration, all the evangelical organizations of Chile in the Evangelical Council, expressed their loyalty to Clifton Erickson and took upon themselves his defense against all the unjustified attacks of which he has been a victim. "Rev. Erickson," declare the evangelicals, "is not a charlatan, spritualist, healer or a witch doctor, as some people would like to call him, but he is a great man of faith." This is the definite expression of the evangelicals, which completely destroys all the absurd fables knit around the activities of the Northamerican pastor.

The following is the main text of the declaration made public by the Evangelical Council, representing 500 thousand evangelicals in Chile:

The Chilean evangelical people, grouped together in the Evangelical Council and other evangelical organizations of Chile, backs and supports unconditionally Rev. Clifton Erickson in his campaign in our country for the following reasons:



Because he preaches and teaches ac-cording to the Bible.

Evangelicals in all the world recognize and accept the Bible as the inspired Word of God and as a standard of Christianity, recognizing its teachings as the Voice of God to a world of sinners. Reverend Erickson, in his campaign, has as his text, the BIBLE and all of his teachings are in accord with what it teaches. Therefore, Rev. Erickson is not a charlatan, a spiritualist, a healer or witch doctor as many people would like to call him, but he is a great man of faith, and a talented and inspired expositor of the Holy Scriptures.

2. Because Miracles are Biblical.

The act of performing miracles is clearly and explicitly shown in the Bible. The Lord Jesus performed miracles when He walked this earth. The Apostles and disciples of our Lord Jesus performed miracles and moreover, He Himself said that those that believed in Him, would do even mightier things than He did in His Name.

Because the Bible establishes the Doctrine of Healing.
 Healing of the sick through faith in God

is a teaching shown very clearly in the Bible and is established in the four square doctrine of the Scriptures: Christ, the Saviour; Christ the Sanctifier; Christ, the Healer; and Christ, the Soon-coming King.

We find the doctrine of healing by faith We find the doctrine of nearing by later and prayer given in Mark 16:18, where it says: THEY SHALL LAY HANDS ON THE SICK AND THEY SHALL RECOVER. In James 5:14, it says also, "Is any sick among you? let him call for the elders of the church, and let them pray over him." of the church; and let them pray over him.

In conclusion, we, the evangelicals, are backing Mr. Erickson because he is making legitimate use of Religious Liberty granted us in Article 10, Number 2, of the Political Construction of the Government, of which we, as Chilean citizens, are very proud.

In view of the above reasons, we believe and uphold that Rev. Erickson deserves the respect of all and he is worthy of enjoying the prerogatives which our Constitution gives to all men who respect our laws.

Thirty-nine dignitaries, representing all the evangelical churches in Chile, signed the declaration which opposes the questioning machinations of the Catholics in their blind opposition to Rev. Erickson. The list of churches backing this campaign is as fol-

OSBORN TRIUMPHS IN VENEZUELA Despite Persecution, Arrest, Interference

MISSIONARY W. C. STEPP WRITES

CONCERNING PUNTO FIJO CAMPAIGN:

"More than 5,000 in one service asked to be saved"

The second Osborn Campaign in Venezuela opened in Punto Fijo, in the State of Palcon. The first night there were about 5,000 people present to witness the miracle-working power of God. The second night doubled the attendance with an estimated crowd of 10,000. It was at this service that more than 5,000 people sincerely and earnestly manifested their desire to be saved. They prayed the prayer of repentance, and expressed their desire to attend the local Pentecostal church and serve the Lord faithfully.

To our further amazement, the third night was even larger. An estimated 12,000 to 15,000 people attended, and again over half of the crowd prayed for salvation. The fourth day the priests and doctors worked hard to oppose and close the meeting. In fact, the whole town seemed to have vacated the shows, dances, bars, poolrooms, etc., to attend the campaign. The authorities called us all into

the agency office where for over an hour it was necessary to answer their questions and refute their charges that witchcraft and deception were being practiced. Having convinced the authorities that the people were being healed by the obtaining of faith through the preaching of the Bible, they then tried to prohibit the meetings saying we did not receive a permit for the open air meeting. This we quickly handled by presenting the permit that the city mayor had granted us. Upon arriving at the meeting site about 6:00 p. m., we were told by police that the meeting had to stop, even though several thousand people were present already. The police left when we showed them the permit from the mayor, but an hour later two more police walked up on the platform and told us to dismiss the meeting at once. Again we showed our permit and again the police left.

About 10:00 P.M., after all had left the

grounds, several squads of police, detectives, radio patrols, etc., came and with long drawn "machete" swords, clubs, and badges, brutally ordered us all into the patrol wagons under arrest, and took us to the police station to answer charges before the authorities. What charges?—PREACHING THE GOSPEL OF JESUS CHRIST WITH SIGNS FOLLOWING!

After an hour of questioning the mayor spoke of having dug up some old law stating that it was prohibited to conduct religious services outside the church. Thus, the mayor himself, who had originally issued the permit to us, revoked it, and demanded the meetings stop, and gave us less than 15 hours to clear out the field, platform, lighting, etc.

Realizing that it would be impossible to conduct great open air campaigns in Venezuela, Rev. Osborn left for Costa Rica where a large stadium was awaiting him.

We who remain in Venezuela are determined to continue this great work of Christ that Bro. Osborn was privileged to begin for us. To God be all the glory!

BLIND MEN SEE:

These two men give glowing testimonies of being healed of blindness as Bro. Osborn prayed. Calle Trinidad, on the left, asked friends to lead him to the meeting. The first night, after the evangelist prayed for all the sick people at one time, Calle took his hands off his eyes and could see light! He was happy for he knew he was being healed. He went home rejoicing over all he had heard, and the next morning he could see objects! Clearer and clearer became his sight until he could see everything!

Punta Cardon, right, laid his hands on his eyes when Bro. Osborn told all those with eye trouble to do so while he prayed, and when the prayer was finished, he could see hundreds of little black spots. He kept believing, and in a few moments those spots began to fade away and everything was clear. Now he claims good eyesight.





The Coming Presidential Election

and Prophecy

Astounding Facts Revealed by the 666-Day Time Measure Reveal the Sinister Direction America is Heading .

THE number 666 is the number of man. It has been supposed that this number refers only to the Antichrist and the false prophet, but actually it is also the number of man and his ways, opposed to God and His ways.

THE SINISTER SIGNIFICANCE OF THE NUMBER 666 IS REVEALED IN THE BOOK OF REVELATION:

"Here is wisdom. Let him that hath understanding count the number of the beast; for it is the number of a man; and his number is Six hundred threescore and six." (Rev. 13:18)

The number 666 startlingly identifies the direction that America has been drifting in recent years. It must not be supposed that the number 666 is connected entirely with developments that have been taking place in one particular political party, but in fact is sinisterly involved in the whole stream of events of recent years.

THE PLAN OF WASHINGTON, D. C. WAS DESIGNED FOR 666 DOLLARS

Not long ago an article syndicated by the NANA appeared under the dateline of April 18, 1951, which tells an interesting story of the founding of Washington, D. C. It declared that one Pierre Charles L'Enfant, conceived the plan of the city. The interesting point was that his price for designing the city of Washington was \$666.56! In the year 1810, Congress passed a bill appropriating that amount with interest.

ROOSEVELT AND THE NUMBER 666

No one may deny that in the last generation, tremendous changes have been taking place in the political structure of the United States. Have they been for better or for worse? Many people are apprehensive over the changes that are being wrought. Our recent trip to Washington confirmed the conviction that many of our leaders in Washington feel the same way. Only one congressman we met felt that all was well. He indeed thought the world was getting better, day by day, in every way, but few of his colleagues shared his optimism.

The profound change, of course, came during the New Deal administration of Franklin D. Roosevelt. The Great War followed by the Great Depression left the nation in a precarious condition, economically and spiritually. The collapse of the Stock Market and the panic that followed rendered insolvent a large fraction of the nation's businesses. The time was ripe for a great change. Roosevelt offered the nation the so-called New Deal, and sought nomination as a Democratic candidate for the presidency of the United States, realizing that whoever won at the convention would surely

be elected president in the coming November election.

The competition was intense between rival candidates. Breathlessly the convention at Chicago watched the tallying of the votes of the delegates on the first ballot. It was soon clear that Roosevelt was in the lead. Presently the tellers had the answer of the total—it was 666 for Roosevelt! The rest of the balloting was a matter of routine. Roosevelt became the presidential candidate of the Democratic party. His election the following November was a foregone conclusion.

THE NUMBER 666 IN U.S. HISTORY

While the number 666 appears most significantly in the nation's history since the inauguration of Roosevelt, it must not be thought that this number is unique only to his administration. This sinister number originated its cycles long before he became president.

On November 11, 1918, the Armistice of World War I occurred. Hostilities ceased and the news was flashed to all parts of the earth. Church bells rang, whistles blew, sirens screamed. People gathered in great throngs and abandoned themselves to the hysteria of that hour. The "war to end war" was over. Statesmen proclaimed that a new era in the history of the world had dawned. Modernist preachers, blind leaders of the blind, proclaimed that a Millenium of peace was at hand. Business boomed and economic prophets proclaimed "good times" ahead. Stocks and bonds soared to dizzy heights, and the country settled down to an orgy of Wall Street gambling and "get rich" quick schemes.

STOCK MARKET CRASH OCTOBER 20-27, 1929

(6 x 666 days from the Armistice)
Then came Black Friday during the week of October 20-27, 1929. It was a historic day. On that day the prosperity bubble had burst and the bottom fell out of the Stock Market. Billions of dollars were lost in hours. It was God's Handwriting on the wall. The Great Stock Market Crash had come exactly 6 x 666 days from the Armistice! (Note that I Kings 10:14 associates the number 666 with gold, the basis of world finance.)

THE NRA—JUNE 13-20, 1933 (8 x 666 days from the Armistice)

The Stock Market Crash brought on the Great Depression. Things went from bad to worse and the people clamored for a change. The elections of November, 1932, swept Mr. Roosevelt and the New Deal into power. He became president at a time when the wheels of industry and business had almost stopped.

Of the many laws that were hurriedly passed, there was one that was to revolutionize, for the period of its existence, the economic system of the nation. It was the NRA, or the National Industrial Recovery Act. Under its banner, swift regimentation of industry began. Every business received its code; upon each window went the sign of the Blue Eagle. Any manufacturer who failed to line up was to be blacklisted. Some thought that the Blue Eagle of the NRA was the Mark of the Beast. It was not. But it was marked by the number of 666—the NRA was enacted law on June 13, 1933, just 8 x 666 days after the Armistice!

PLAN TO CHANGE THE SUPREME COURT— FEBRUARY 4-11, 1937

As the passage of the NRA was the distinguishing event of the first administration of Roosevelt, so his attempt to change the Supreme Court was the outstanding event of the second term. The Supreme Court had outlawed the NRA, as well as many similar laws, declaring them unconstitutional. Therefore a few days after the New Deal Administration was returned to office, the president presented the country with a plan to change the Supreme Court! This was the so-called plan to "pack the supreme court" with New Deal justices. The startled country, however, swiftly reacted against the president's proposal and Congress refused to make it law.

What was the significance and character of this unprecedented attempt to control the Supreme Court, thus centralizing power in an unprecedented way in the hands of the president? The time-measures tell the story. The Supreme Court bill was introduced on February 4-11, 1937, just 10 times 666 days from the Armistice!

Though the bill was defeated and the integrity of the Constitution remained intact, the full objective of it was shortly attained. Several of the justices died, and another resigned! The vacancies, of course, were filled with New Deal appointees.

THE ROME-BERLIN-TOKYO AXIS, SEPTEMBER 27, 1940

(12 x 666 days from the Armistice)

In the meantime the Great Depression in Europe spawned Hitler who plunged that continent into a fearful war. In September 1940, for the first time in American history, came peace-time conscription. But the great event of this time took place on September 27, 1940-the formation of the Rome-Berlin-Tokyo Axis-a development that destined America to become involved in World War

This historic and sinister event of the formation of the Rome-Berlin-Tokyo Axis occurred on September 27, 1940, just 12 x 666 days after the Armistice!

D-DAY—INVASION OF THE **IRON FORTRESS** JUNE 6, 1944

(D-Day occurs 14 x 666 days from the Armistice)

These particular time-measures were noted by the writer in the year 1940. Seeing how remarkably they were being fulfilled, early in 1944, he published an article venturing to remark that D-day "might come 14 x 666 days from the Armistice, that is at the end of May or the first few days of June, 1944." Of course, he had no way of being sure of this, except that such an event would be in line with the significance of these time-measures. But even he was startled to learn that D-Day not only took place at this time, but it was on June 6, 1944—at the 6th hour of the 6th day of the 6th month! The three sixes again!

Fourteen is one of the numbers of completoness, and apparently this series of time-measures has now been completed. however, has told its significant story. The series came to a conclusion with America on the continent of Europe, where according to prophecy the Beast Power in all its fury, shall one day rage. (See Rev. 13 and

SIGNIFICANCE OF THE ELEC-TION NEXT NOVEMBER

What is the significance of the coming election next November? In answer to this question, let us notice another significant series of 666 day cycles. These time-measures originate with the beginning of World War I, or during the week of July 28-August 4, 1914, during which week most of the nations of Europe were drawn into the First Great War.

THE LEAGUE OF NATIONS BORN JANUARY 10-16, 1920

(3 x 666 days from the beginning of World War I)

After World War I had ended it was the hope of statesmen that with the creation of a League of Nations, the world would be ushered into an era of peace. Men unacquainted with the prophecies (which showed that the age would end in the frightfulness of Armageddon), vainly dreamed that by this League of Nations, vainly the world would avert war in the future. Significantly the nature of that now defunct League of Nations is revealed in that it was

born on January 10, 1920, thus marking it with the number 666—for that date was 3 x 666 days from the beginning of World War II

U. S. ATTACKED AT PEARL HARBOR DECEMBER 7-8, 1941

(15 x 666 days from the beginning of World War 1)

On December 7-8, 1941, Japan brought America into the War by her sneak attack at Pearl Harbor. What was the prophetic significance of that date? On January 10, 1920, the League of Nations was created to prevent war. Just 12 x 666 days later America was forced into a second great world conflict. The infidel denies that there is a design or order in world events, but these time-measures show how utterly he is wrong. Any man who refuses to believe that God overrules the events of this world is indeed blind. God makes even "the wrath of man to praise Him." (Note that Pearl Harbor came 15 x 666 days after the beginning of World War I).

THE ATOMIC BOMB AND END OF WORLD WAR II **AUGUST 1-14, 1945**

(17 x 666 days from end of World War I) America was in the war just 2 x 666 days. During the first week of August, 1945, atomic bombs fell on Hiroshima and Nagasaki, bringing a swift conclusion to the conflict. The revelation of the Atomic bomb and the end of World War II came there-

fore 17 x 666 days from the beginning of World War I!

THE NORTH ATLANTIC PACT **ANNOUNCED MARCH 18-24**

(19 x 666 days from the beginning of World War I)

Despite the protests of every wide awake minister of the Gospel, American statesmen believed Russia, when she said she wanted peace. Any student of prophecy knew that Russia lied. Now everybody knows she lied. Shortly after the end of the war, Russia began to systematically gobble up one country after another, by the process of infiltration, treachery and intrigue. Only at last did our government realize the significance of Russia's actions. Out of this awakening came the announcement of the North Atlantic Pact, March 18-24, 1949. A significant thing about the Pact is that at the present time just 10 European countries are included in the Pact-the identical number revealed by prophecy to be in the confederacy of the Beast Power. (Rev. 17:12). (It must not be assumed that these are the identical nations in the final lineup.) Another significant thing about the Pact is that as a result of it, Eisenhower has been sent to Europe to build an army from the various nations of Europe to resist Communism. But the most significant thing of all, is that this Pact was announced 19 x 666 days from the beginning of World War I!

THE COMING PRESIDENTIAL **ELECTION NOVEMBER 1952!**

(21 x 666 days from the beginning of

World War I)
This series of time measures comes to an end November 1952!—the time of the

American election! This coming election is apparently fateful in the history of the United States. Watch November! Prophecy marches on. The United States having failed China, having failed Chiang-Kai-shek, must now face great odds in Europe. Whoever is elected President of the United States must face the terrible problem of Communism, which is poised to tear at the throat of humanity. Will Eisenhower become president next November, and assume a leading role in the European drama? The facts are before the reader, let him interpret them.

The 21 cycles of 666 days end in the early part of November 1952—the time of the election!—thus evidently ending one era and beginning a new one.

Who can see this fateful march of events toward Armageddon and not walk softly before God. He who continues in sin adds his part to the cumulative guilt that now weighs upon America. REPLYING to questions posed by a group of American newspaper and radio editors who recently toured Europe, Joe Stalin said, "A third world war is no nearer now than it was two or three years ago." However, the record of his statements in the past indicates that what he says has never seemed to have much bearing on what he does. There also seems to be a disagreement on the issue of a third world war between Stalin and his deputy foreign war between Stalin and his deputy foreign ministry, Jacob A. Malik. A few months ago, in United Nations debate, Malik said: "The third World War has in fact commenced— in Korea, Indo-China, Tunis and Morocco." The main issue of Stalin's reply is focused at present upon Germany. The Soviet Prime

Minister said he considers the present moment opportune for unification of Germany. This statement perhaps is far more significant in the light of his intentions for West Germany than appears on the surface. It is no secret that Stalin wants to include West Germany in the orbit of Communist control and domination. Every indication points to a feeling of urgency in Moscow about Germany at this particular time.

General Dwight D. Eisenhower, in reporting the progress made by the Allied Powers in Europe during the past year, said: "As of today, our forces couldn't offer prolonged re-sistance east of the Rhine barrier," in the event of a Communist move westward across Europe. It appears the Russians already have a Red German Army in the guise of East

German police and now they seem to be in the midst of a deadly serious campaign to knock the very heart out of European defense.

The prophecies of Daniel and Revelation seem to indicate that all of Germany, East of the Rhine, is destined to come under Russian control and domination in the end time when the antichrist shall step forth into his appointed place of authority. The present trend in Central Europe is following the pattern of prophetic revelation and reveals how near we must now be to the coming again of Christ.

MORE PERPLEXITIES

IRST we gave Russia \$11,000,000,000 to hold back Germany (during World War II). Now we have given Germany \$250,000,000 to hold back Russia. We spent billions and we have over 100,000 casualties in Korea— 8,000 miles away—to stop North Korea from over-throwing the South Korean government by force. A few months ago the Cuban government was overthrown by force right on our doorstep and we do nothing about it.

How confused and muddled can men and governments get? These, and other tragedies in world affairs today, only show how utterly confused and bewildered are the diplomats and world leaders in this hour of history. Bible prophecy plainly speaks of this 'confusion' in the last days as men and nations ignore God in their planning and actions. There will be no peace and stability until the Prince of peace returns, and surely He must be coming soon.

HAILSTONES

PROPERTY damage estimated at \$1,000,000 was done in Phoenix, Arizona, recently during a hail storm. "About 40 small frame houses were destroyed, and more than 40 airplanes were damaged at the airport." Several persons were injured by the hail stones about the size of eggs.

A barrage of large hailstones caused an estimated \$1,500,000 damage recently in Joplin, Missouri. The storm lasted only about 10 minutes, hitting the city in two waves with a loud roar which awakened most of the city's 40,000 inhabitants. Many thought a tornado was sweeping the city. Roofs of nearly 8,000 buildings were wrecked or damaged by the hail, some as big as nine and one-half inches in circumference.

The day is coming when there will "fall upon men a great hail out of heaven, every stone about the weight of a talent (90 pounds)." Rev. 16:21.


NUMBERS
